### 2. Open Positions:

- Assistant/Associate Agent, Commercial Horticulture: The search with Another Source
  was discontinued after receiving only one underqualified application. Low interest may be
  tied to the University of Arizona's financial image.
- Extension Assistant (4-H): The hiring freeze was lifted on July 1, and recruitment is expected to begin soon.

## Cooperative Extension Strategic Positioning

- Input from listening sessions is being analyzed by external consultants, with findings expected to be shared at the Extension Annual Conference in the fall.
- Concerns were raised about the session's format, perceived underrepresentation of rural voices, and low participation.

### **Advisory Board Member Updates**

- Amber Morin: Announced the release of the Fort Huachuca Sentinel Landscape documentary on August 2 at the Bisbee Royal Theater and invited board members to attend.
- Nathan Watkins: Expressed gratitude for his recovery and provided an update on his nephew's
  accident.
- Ron Bemis: Discussed the ongoing Douglas AMA meeting, which is reviewing Arizona water statutes and related documents.
- Dennis Moroney: Highlighted issues with neighbors not adhering to the "Fence Out" law for openrange ranching and emphasized the need for stronger rancher advocacy.
- Aaron Cardona: Voiced concerns about the growing anti-agriculture sentiment among new residents. Shared his experience attending the University's strategic planning session.
- Tyler Curry: Noted increased activity at the Sunsites water fill station, reflecting changes in local water use.
- Alan Seitz: Reported on water conservation efforts among Cochise County growers, emphasizing
  efficient irrigation methods like pivots and drip systems.
- Jason Zibart: Shared updates on grant projects, including a new farmers market in Benson, operational success of the mobile MRI, and efforts to establish a fund for future upgrades.
- Moiria White: Praised the success of the 4-H Large Stock Activity Day, which saw over 100
  attendees. Highlighted challenges in recruiting volunteers and noted that Haley's support is
  expected to help with volunteer engagement.
