Internship Description

The Natural Resource Users Law and Policy Center, in conjunction with Cooperative Extension at the University of Arizona, offers a spring hybrid in person and online internship. This internship is a unique chance for students interested in agriculture, natural resources, and state and federal policy. Interns will have the opportunity to engage with a natural resource industry political organization on several fronts, including policy, communications, and membership, and will work closely with the lobbying and regulatory teams to advance policies important to natural resource industries.

The student will gain a broader understanding of the political landscape regarding natural resources in Arizona. College credit hours will be offered through the University of Arizona. Students must work with their academic advisor to sign up for 3 credit hours on their own for the Spring Semester. Personal transportation will be needed periodically for travel to and from Phoenix for organizational and legislative activity.

The Natural Resource Users Law and Policy Center is a creative partnership of the University of Arizona James E. Rogers College of Law and Cooperative Extension that grew out of grassroots discussions. The center's roles include collaborating with stakeholders, mentoring students, providing legal and policy analysis, and addressing underrepresented law and policy needs of the natural resource community of Arizona and the West.

Expectations:

• Students will attend two in person meetings at the beginning of the semester with the Policy Cats Intern Cohort.

- Students will then interreact weekly with their assigned organization, either virtually or in person as needed.
- Students will check in their cohort leader weekly.
- Students will come back together in person at the end of the semester for a final meeting to share learned experiences from internship.
- All dates to be determined between internship coordinator, Taylor Rogers, and selected interns to best fit their schedule.
