

Advanced Design of Onsite Wastewater Treatment Systems: Exact Topic TBA

This is a 1-day course on designing onsite wastewater treatment systems using pressure distribution and systems incorporating pumps into the design using the Arizona Administrative Code. Course will also cover installation, inspection, and operation & maintenance issues regarding pumps. Please bring a calculator and writing implement. **Prerequisite:** All participants will need to have completed both the NAWT Inspection Training and Soils & Site Evaluation courses. **Other Certification:** This class qualifies for 8 CEU hours for renewing your NAWT certificate.
