

## Introduction to Design of Onsite Wastewater Treatment Systems

This is a two-day course on designing onsite wastewater treatment and dispersal systems using Arizona regulations primarily for gravity distribution and residential applications. A homework assignment will be used to provide practical application of material learned in the workshop. Please bring a calculator and writing implement. Prerequisite: All participants will need to have completed both the NAWT Inspection Training and Soils & Site Evaluation courses.
