Conduct at Fair: Please remember, 4-H & FFA are guests of the Pima County Fair. While at the County Fair, we must abide by both the Pima County Fair Code of Conduct and the 4-H Conduct (And FFA Code of Conduct if Applicable). Additionally, the fair is a public event and the barn is an open area for the public to enter, and therefore, please make all necessary arrangements for management of 4-H and FFA members and other youth as this not a 4-H Only Event.

1. There is no longer a Food Booth that we will be pre-selling tickets for this year. The SWFC is searching for an affordable alternative, however there will not be any pre-sale vouchers available at this time.

While tickets will be available at the April 11th workday for individual purchase, it is highly recommended that tickets be ordered through your community club leaders. Tickets will not be sold after 12:00 noon on the April 11th, 2020 Fair Workday.

*Wristbands must be affixed to wrist without the ability to be slipped off by the wearer. Loose wristbands are subject to confiscation ... please do it correctly the first time. Thank you for your cooperation.

*All 4-H members and family members will be required to have admission and parking credentials to enter the fairgrounds or they will be required to pay upon arrival. This includes all project areas including horse project participants and families. To avoid any problems upon arrival, please help us by letting your members know that all eligible 4-H and FFA participants and families have the opportunity to purchase these discount admission wristbands in advance. Each 4-H family receives one free parking passes and must indicate this on their order form, one additional parking pass may be purchased for \$5.00, and detailed on the order form.

Fair Parking

Fair parking is \$5.00 per vehicle per day. Persons not in possession of the one free parking passes provided or purchasing the \$5.00 pre-sale parking credential will be required to pay the daily fee upon arrival. Only one (1) vehicle with a special \$5.00 parking credential will be allowed to park in each RV /Trailer space behind Pima Hall in the 4-H RV Park. This \$5.00 parking credential must be ordered on the Campground Form when a camp space is reserved through Tracy Nielson.

Vehicles without a parking hanger or improperly parked will be towed at owners' expense. **"NO REFUNDS WILL BE GIVEN"**

Drop Off of Supplies and/or Feeding Parking Lot:

A new lot by the Livestock Ramada will be available to drop off supplies or feed prior to the Fair opening each day. Those wishing to utilize that lot must check in at the Brekke Rd. Gate, obtain a 30-minute time limit parking permit. An attendant will be standing by at this location. If the vehicle is left beyond the 30 minutes time limited noted on the pass, the vehicle will be subjected to be towed. Persons dropping off such supplies should be prepared by bringing the necessary equipment to unload supplies such as hand truck or wheelbarrow.

Campground Spaces:

4-H & FFA families can stay at the fairgrounds in motorhomes and RVs. An application with prices for camp spaces and Campground Rules are enclosed. Tracy Nielson, at tracyn314@gmail.com will coordinate camp assignments. Tracy requests that applications be mailed individually. Camp space requests will be reviewed after March 1, 2020 and are due no later than March 30, 2020.

4-H & FFA Families can stay at the Fairgrounds in motor homes and RV's in accordance with the campground rules. Only one (1) vehicle will be allowed to park at each RV/Trailer or Dry Camp space during the Fair and each vehicle pass will cost \$5.00. ALL spaces with hookups are 50 amps so be sure and plan your trailer adjustments to allow the connection between the RV /Trailer to the 50-amp receptacle. The new RV Office in the 4-H RV Park sells the 30 amp to 50 amp adapters at a reasonable price. RV Park guests may contact the office directly at (520) 762-8579 or email at info@the-rvpark.com or website the-rvpark.com.

4-H RV Camping Amenities and Services:

The Fairgrounds RV Park offers several amenities and services available to use by Fair RV Park users. Propane is offered for sale daily between the hours of 8:00 am and 5:00 pm. Pricing for propane is **currently** \$2.75 per gallon but is **subject to change**. Do it yourself laundry is available 24 hours per day on a first come first served basis at the south side of the new RV Office. Change is available for laundry machines during regular RV Office hours from 8:00 am until 10:00 pm daily. Restrooms and showers are available at two locations for 4-H RV Park users. The first location is inside the Livestock Barns and is open 24 hours per day with restrooms and showers available on a first come first served basis. The second location is at

the new RV Office with restrooms at the east end open 24 hours and private showers available on a first come first served basis between the hours of 8:00 am and 10:00 pm and a key may be checked out for access with a photo ID.

Fair Hours:

Weekday opening for the main admission gate is 2:00 pm, and the carnival opens at 3:00 pm. Weekends the main gate opens at 10:00 am and the carnival opens at 11:00 am. Friends or family members wishing to attend Open, 4-H or FF A events & activities prior to main gate opening may enter early and pay for admission through Brekke Gate.

Parking Lot Cleaning:

We have four (4) lots to be cleaned daily and the Fair will donate \$250.00 per day to the club that cleans the following four lots:

Red Parking Lot, Blue Parking Lot, Green Parking Lot and the Brekke Gate 4- H Parking Lot.

Animal Welfare and Public Safety :

The Pima County Fair has developed an Animal Welfare and Public Safety Policy to ensure a safe and enjoyable fair experience. Due to the recent Equine Herpes Outbreak and other potential communicable equine ailments, the Pima County Fair has implemented extra procedures to minimize the possibility of any chance of spreading disease at the Fair. 4-H Horse project participants and other project participants should make sure that their animals have all the updated immunizations prior to coming to the fairgrounds. It should be noted that preparing, serving, or eating food is not allowed in animal exhibit areas or the livestock barns. Please see attached policy for the details.

Animal Welfare and Public Safety at the Pima County Fair

The Pima County Fair provides educational and informational opportunities about agricultural issues. These include the care, raising, handling and housing of many domestic species that are exhibited or displayed by 4-H and FFA members. Animal attractions must provide current permits for participation prior to arrival at the Pima County Fair grounds in addition to passing daily inspection by the Pima County Fair veterinarian to determine the wellness of the animals.

In recognition of the Equine Herpes outbreak, the Pima County Fair is being proactive in preventing the spread of this disease. Horse stalls are completely cleaned of waste and bedding after each use then sprayed with a Symbiont solution. Symbiont is used in the equine industry to cleanse areas that are prone to host pathogens, viruses, bacteria and fungi. Symbiont is safe and non-toxic to animals and their surroundings and is sprayed between shows, before horses arrive and after they leave the fairgrounds equine stalls.

The Southwestern Fair Commission, Inc. carefully monitors the conditions of livestock during the Pima County Fair and entrusts the enforcement of code, animal welfare and confinement of animals exhibited by junior exhibitors to the Pima County Extension Office. State and local veterinarians Dr. Staten and Dr. Grimbly monitor the health of the livestock and animals in the entertainment industry on the conditions of their confinement as well as responding to medical issues, reports of neglect or abuse of any of the animals during their confinement at the Pima County Fair.

When necessary, issues are first addressed with the Pima County Fair Barn Manager and 4-H, or the attraction operator. If the situation requires further attention, fair staff is notified and respond accordingly. Cases of animal abuse are reported to the Pima County Sheriff's Department. Doctors Staten and Grimbly visit the animals regularly to monitor the proper care and confinement of the animals for the duration of the fair. Cattle are required to be taken out of their holding area, twice daily or as often as needed. One youth exhibitor or adult must remain with the animal at all times. Cattle are tethered to protect the animals as well as the public.

The Pima County Fair will not book an animal attraction where there have been confirmed reports of prosecution for animal abuse or neglect. The Pima County Fair will research the attraction for such reports, prior to soliciting a performance engagement. Attractions who have received a minor citation but have rectified and met the requirements of the USDA, will be considered. Additionally, the Pima County Fair will research the confinement, exercise and transportation of the animals to ascertain the health and wellbeing of the animals during the fair, when it does not compromise public safety. The Pima County Fair prefers animal attractions that feature natural behaviors and animals that were either rescued or born into captivity. All attractions must have the required Pima County and/or the Arizona Department of Game and Fish permits, prior to their fair appearance.

In consideration of the well-being of all fair livestock, animals in the amusement industry and vendors or exhibitors with domestic, wild and/or endangered species, the Pima County Fair contracted veterinarian will conduct a scheduled inspection of the animal containment, confinement, display and mode of transportation for the safety and wellness of the animals. Random inspections will occur throughout the fair.

To help prevent the spread of hand to mouth pathogens related to animal attractions and livestock, hand washing and sanitizing stations are placed near all animal attractions, livestock, bathrooms and near eating areas. Signs reminding the public to wash their hands along with warnings of possible transmission of disease related to animal to human contact are placed directly at each animal attraction. Preparing, serving or eating food is not allowed in animal exhibit areas or the livestock barns.

ATTENTION:

Teachers, Chaperones, Parents and Adults; Please enjoy the fair and help prevent the spread of infectious disease amongst children. Remind children to wash their hands and supervise their handwashing after visiting any animal exhibit and before any food consumption.

Pima County Fair Code of Conduct

We are incredibly excited to have you at the Pima County Fair! We do whatever we can to ensure that all our visitors have an enjoyable, safe time at the Fair. In so doing, the Pima County Fair must enforce prohibited items and behaviors which apply to fairgoers. Listed below are some of the common prohibited items and behaviors, but does not limit itself to the following:

No Fire Arms Allowed: Pursuant to A.R.S. 4-229 *Form 1113*

All bags will be searched. All persons and your property are subject to search.

The following items are NOT allowed into the Pima County Fair:

- Ice chests, outside food or beverages including alcohol
- Weapons or drugs
- Drones
- Selfie Sticks
- Silly String or Squirt Guns
- Hover boards, bicycles, skateboards, roller skates, roller blades, razors
- Gang, inciteful or hateful attire
- Non-service animals
- Solicitation or distribution of promotional materials, literature or vending without prior written consent is prohibited.
- Professional Photography Equipment or Tripods that are not directly connected with a news affiliate
- Video Cameras and other recording devices are not allowed into the concert areas
- *The use of laser beams, flash cameras, both personal and professional may be prohibited in some instances. Information regarding this is posted at the Pima County Fair Main Gate and announcements are made from the stage. Photographing, Video or audio taping of performers can result in your equipment being temporarily confiscated and/or you may be removed from the event.*

The following behaviors are subject to prosecution and may result in being removed and banned from the Pima County Fair, without refund:

- Any illegal activity
- Acts or threats of violence
- Bootleg merchandising
- Counterfeiting of or scalping of tickets, ride passes and/or credentials
- Drunken or disorderly conduct
- Destruction of property
- Possession and/or use of illegal drugs
- Underage drinking
- Bullying



Arizona 4-H Youth Development Youth CODE OF CONDUCT

The University of Arizona Cooperative Extension's 4-H program is committed to providing a safe, fun, and healthy learning environment for youth and adults involved in activities and events sponsored by Arizona 4-H. The personal behavior of each participant is important to the success of all Arizona 4-H events. Each participant must accept their responsibility to represent themselves, their club, their county, Arizona 4-H, and the University of Arizona Cooperative Extension with dignity and pride. Individual behavior shall reflect a healthy respect for self and others in use of language and action. Group behavior shall include safe and appropriate use of public space in a manner respectful of all individuals, including participants and sponsoring organizations or entities. **Participation in 4-H activities is a privilege, not a right. Participation may be terminated at the discretion of authorized 4-H officials pursuant to rules and regulations established by 4-H.**

All youth participants agree to:

1. Work cooperatively with other 4-H participants, youth, volunteer leaders, families, Cooperative Extension faculty and staff, and others in a courteous, respectful manner.
2. Obey the local laws as well as the laws of the state and federal government.
3. The use of any tobacco, alcohol, and illegal drugs/substances at all 4-H events is prohibited.
4. Use of firearms is prohibited, except when part of an approved shooting sports educational program.
5. Present yourself as an appropriate model in dress, manners, conduct, appearance, and actions during all 4-H events.
6. Use, respect and care for all property used. Charges will be assessed for any misuse or damage.
7. Attend planned events as may be required.
8. Know and follow established rules and expected behaviors for all programs and activities in which I participate.
9. Use appropriate language at all times. Abusive or profane language is prohibited.
10. Never resort to the use or threat of physical or emotional violence.
11. Represent the Arizona 4-H Youth Development program with pride and dignity.

4-H Dress Code

The following guidelines are designed to make everyone's experience at 4-H events satisfying to all attending. This means that all participants, members, volunteers, and 4-H YDP staff, shall adhere to the core values of the University of Arizona 4-H Youth Development Program, respect the individual rights, safety, and property of others. The following dress code was developed to prevent participants from becoming offended or uncomfortable during 4-H events. If you choose to dress inappropriately, you will be asked to change, or be required to leave until dress code is followed. By planning you will save yourself the inconvenience of changing your attire to ensure that you contribute to a pleasant atmosphere.

Please be advised that the following dress code will be enforced.

1. Clothing: All clothing shall be neat, clean, acceptable in repair and appearance, and shall be worn within the bounds of decency and good taste as appropriate for 4-H events.
2. Articles of clothing which display profanity, products, or slogans which promote tobacco, alcohol, drugs, sex or are in any other way distracting, are prohibited.
3. Excessively baggy or tight clothing, and clothing which advertises gang symbols or affiliation is prohibited.
4. Items of clothing which expose bare midriffs, bare chests, undergarments, or that are transparent (see-through) are prohibited. Tank tops with straps wider than one inch are permitted. Please be advised that spaghetti straps, shirts which expose a bare back, halter tops, and tube tops are prohibited.
5. Swimming (For all water recreation): Swimsuits for men: swim trunks only (no shorts, cut-off pants, or Speedos).

Swimsuits for women: One-piece suits recommended, however, two-piece suits are allowed as long as they are modestly cut. No string, thong or crochet suits will be allowed. Swimsuits may only be worn while in the swimming pool area.

Pima County Fair 2020 Campground Rules

As a courtesy to 4-H/FFA and Open Division families, the Pima County Fair is pleased to provide the camp grounds as a low-cost lodging alternative to late night travel to and from home or to costlier motels. It is also a privilege to camp at the Fair. Any individual or family violating these rules may be expelled from the camp ground for the 2020 Fair and/or future Pima County Fairs. These rules will be enforced by the Southwestern Fair Commission, its agents and employees. The rules apply to parents, exhibitors, and 4-H/FFA & Open members. Camp spaces are for Open division and 4-H members and their families.

1. The Campground is equipped with 50-amp service. It is your responsibility to provide the correct connection for your electricity. 50-amp adapters for trailers are available for purchase at the fairground's RV Office. For more information and pricing, you can call the RV Office at (520)762-8579
2. Exhibitors **must** have a parent or legal guardian in residence at the camp space all night. All Exhibitors are to be at their camp space by midnight without exception.
3. Alcohol, Firearms and Fireworks may not be brought onto the Fairgrounds and are not permitted in the campground area.
4. Camping must be in designated areas only. Camping must be in recognized camping facilities; i.e., motor home, camp trailer, etc. Camp Spaces in the main lot are for RV only. Tent camping is available in the tent area located east of the dry lot. **No generator use between 12 am and 6am.**
5. **4-H/FFA and Open Member Curfew is 12 midnights. Noise curfew in the campgrounds is 10:00 p.m.**
6. NO open fires (including hibachi, barbeque grills, and other containers). Gas propane grills are allowed.
7. All RV's are required to have an "O" Ring for sewer connections and water hoses that do not leak.
 - o Your sewer hose must be connected to a donut or a sewer hose connector
 - o Do not place your sewer hose directly into our sewers. This causes a backup of our sewer system and emits toxic gases. You can purchase the proper connectors at the RV Office
8. Unlicensed drivers are not permitted to operate any motorized vehicles on the Pima County Fairgrounds. No ATV's, motorcycles, golf carts, scooters or bicycles will be allowed on the County Fairgrounds. Vehicles will adhere to the 5-mph speed limit at all times.
9. PET OWNERS MUST CLEAN UP AFTER THEIR PETS. Pets must always be on a leash and someone in attendance. You will be asked to remove animals from the Fairgrounds if any complaints, such as excessive barking, and aggressive behavior are made during the Fair.
10. Backflow prevention –Federal and State law require that water suppliers protect their water systems from contamination. Residence used for other purposes, as well as commercial and industrial customers are required by The Arizona Administration Code rule R18-4-215 to install and maintain backflow prevention assemblies. **DO NOT remove the Yellow backflow preventer located on the water spigot at your RV Site, Charges will be applied if removed.**

4-H Workday Schedule:

Three work days will take place this year, the first day is set for Saturday February 29 from 8:00 am to noon for the Livestock Ramada set-up, (SAILA event dates are March 6-8), the second work day is Saturday April 4 from 9:00 am to noon for Old Pueblo Hall set-up and the third work day is Saturday April 11 from 8:00 am to 1:00 pm for Barn and any other areas remaining.

Carnival Ride Presale Promotion:

As in the past we are selling, 10 rides for \$15, good Monday through Friday only. However this year they will be sold online on our website only at www.pimacountvfair.com beginning Monday January 20-Wednesday April 15, 2020.

Fair Admission and Parking:

The forms are attached for you to print and distribute to 4-H families and leaders for ordering Fair admission wristbands and parking credentials. We did not produce duplicate forms this year. We are asking that when leaders turn in their order with the Club Order Form, they include a copy of each Family Order Form, that was turned into the club leader. That will allow us to keep track of the number of parking passes and wristbands that are supposed to be sold per family. The pricing for eligible 4-H members, leaders and family members is as follows:

Fair Admission Wristband - youth 5 & under	FREE
Fair Admission Wristband - ages 6-10	\$6.00 each
Fair Admission Wristbands – ages 11 and over	\$15.00 each
Parking Pass Brekke 4-H Lot (limit one per family)	FREE
Parking Pass Brekke 4-H Lot (limit one additional per family)	\$5.00 each

***Wristbands must be affixed to wrist without the ability to be slipped off by the wearer. Loose wristbands are subject to confiscation...please do it correctly the first time. ALL Parking stickers MUST be affixed to the window of the vehicle, refusal to do so will result in parking sticker confiscation and no refund.**

****ALL 4-H MEMBERS AND FAMILY MEMBERS WILL BE REQUIRED TO HAVE ADMISSION AND PARKING CREDENTIALS TO ENTER THE FAIRGROUNDS AT ALL TIMES OR WILL BE REQUIRED TO PAY THE DAILY RATE UPON ARRIVAL. THIS INCLUDES ALL PROJECT AREAS I.E. HORSE PROJECT PARTICIPANTS, SHOOTING SPORTS, FEED AND BEDDING DROP OFF, ETC. AND THEIR FAMILIES. TO AVOID ANY PROBLEMS UPON ARRIVAL, PLEASE HELP US BY LETTING YOUR MEMBERS KNOW THAT ALL ELIGIBLE 4-H PARTICIPANTS AND FAMILIES HAVE THE OPPORTUNITY TO PURCHASE THESE DISCOUNT ADMISSION WRISTBANDS IN ADVANCE. PARKING IS VERY LIMITED! FOR THIS REASON, FAMILYS MUST PRE-PURCHASE PARKING PASSES AND MUST INDICATE THIS ON THEIR ORDER FORM.**

Fair Parking:

Regular Fair parking is \$5.00 per vehicle per day. Persons not in possession of a pre-purchased 4-H parking pass will be required to pay the daily fee upon arrival and park in the general lot.

4-H Parking Lot:

Families eligible to purchase credentials through the 4-H program will receive only one (1) free parking pass for the Brekke 4-H Parking Lot. Each family will be eligible to purchase only one (1) additional parking pass for the Brekke 4-H Parking Lot.

4-H RV Lot:

4-H members, families and leaders eligible to purchase an RV space for the Fair will receive only one (1) parking pass for the RV Park, no additional RV Lot parking passes will be sold due to limited parking available.

Parking stickers must be affixed to the vehicle window or parking hangers must be hanging from rear view mirrors, refusal to do so will result in parking sticker or hanger confiscation with no refund, and the driver will be required to pay the daily \$5.00 fee and park in the general parking lot, NO EXCEPTIONS.

PARKING CONDITIONS:

Parking hanger must always be hanging from mirror or sticker must be affixed to the window and is nontransferable. Lost or damaged hangers must be repurchased for \$5.00. Park at your own risk. This is a license and not a bailment. In consideration thereof, you agree that Southwestern Fair Commission, Inc. dba Pima County Fair shall not be liable for damages resulting from injuries or damages to you, other persons accompanying you,

your vehicle, or any contents thereof. You hereby waive and release Southwestern Fair Commission, Inc. dba Pima County Fair from any claim for such damage or loss whether resulting from fire, theft, or otherwise. Vehicles without a parking sticker, parking hanger, daily parking receipt or improperly parked will be towed at owners' expense.

***NO REFUNDS WILL BE GIVEN**

Drop Off of Supplies and/or Feeding Livestock:

Open, 4-H and FFA wishing to drop off supplies or feed livestock prior to fair opening each day may do so but must have the proper credentials to enter the grounds and must park in the designated areas. In order to access their designated area beyond Brekke Gate, ALL persons must be in possession of a pre-purchased parking and admission credential, NO EXCEPTIONS. Brekke Gate staff will direct individuals to their loading and unloading area based on the credentials they have in their possession. Persons dropping off supplies should be prepared by bringing the necessary equipment to unload supplies such as a hand truck or a wheelbarrow.

4-H Campground Spaces:

Tracy Nielsen is coordinating 4-H camping during the Fair. For any questions regarding 4-H campground space rental contact Tracy Nielsen at tracyn314@gmail.com. Preference will be given to 4-H members, families, leaders, coordinators and then to extended family if space is available. Tracy will provide the forms to the 4-H Office for distribution. Eligible 4-H families can stay at the Fairgrounds in motor homes and RV's in accordance with the campground rules. Only one (1) vehicle will be allowed to park at each RV/Trailer or Dry Camp space during the Fair and only (1) vehicle pass will be included with the RV Park space purchase. ALL spaces with hookups are 50 amps so be sure and plan your trailer adjustments to allow the connection between the RV/Trailer to the 50-amp receptacle. The RV Office in the 4-H RV Park sells the 30-amp to 50-amp adapters at a reasonable price. Tents are allowed in the dry camp area ONLY, they are not allowed in the RV Park. RV Park guests may contact the office directly for office hours, price, and availability.

4-H RV Camping Amenities and Services:

The Fairgrounds RV Park offers several amenities and services available to use by Fair RV Park users. Propane is offered for sale daily between the hours of 8:00 am and 5:00 pm. Pricing for propane is currently \$2.75 per gallon but is subject to change. Do it yourself laundry is available 24 hours per day on a first come first served basis at the south side of the RV Office. Change is available for laundry machines during regular RV Office hours from 8:00 am until 10:00 pm daily. Restrooms and showers are available at two locations for

4-H RV Park users. The first location is inside the Livestock Barn and is open 24 hours per day with restrooms and showers available on a first come first served basis. The second location is at the RV Office with restrooms at the east end open 24 hours and private showers available on a first come first served basis between the hours of 8:00 am and 10:00 pm and a key may be checked out for access with a photo ID.

Fair hours:

Weekday opening for the main admission gate for the Fair is 2:00 pm, the carnival opens at 3:00 pm. Weekends the main admission gate opens at 10:00 am, the carnival opens at 11:00 am. As in the past, friends or family members wishing to attend Open, 4-H or FFA events & activities prior to main admission gate opening may enter early and pay for parking and admission at Brekke Gate.

Parking Lot Cleaning:

If the 4-H clubs would like to do the daily clean up in the parking lots for a fundraiser at the Fair again this year, those interested should contact Tracy Nielsen (520) 444-3014. We have four (4) lots to be cleaned daily and the Fair will donate \$250.00 per day to each club that cleans the four (4) lots:

Red Parking Lot, Blue Parking Lot, Green Parking Lot and Brekke Gate 4-H Parking Lot.

Animal Welfare and Public Safety

The Pima County Fair has developed an Animal Welfare and Public Safety Policy to ensure a safe and enjoyable fair experience. Due to the recent Equine Herpes Outbreak and other potential communicable equine ailments, the Pima County Fair has implemented extra procedures to minimize the possibility of any chance of spreading disease at the Fair. 4-H Horse project participants and other project participants should make sure that their animals have all the updated immunizations prior to coming to the fairgrounds. It should be noted that preparing, serving, or eating food is not allowed in animal exhibit areas or the livestock barns. Please see attached policy for the details.

Code of Conduct

In addition, the Pima County Fair has implemented a Fair Code of Conduct that identifies items and behaviors that are not allowed at the Fair. Please see the attached policy for the details.

Animal Welfare and Public Safety at the Pima County Fair

The Pima County Fair provides educational and informational opportunities about agricultural issues. These include the care, raising, handling and housing of many domestic species that are exhibited or displayed by 4-H and FFA members. Animal attractions must provide current permits for participation prior to arrival at the Pima County Fair grounds in addition to passing daily inspection by the Pima County Fair veterinarian to determine the wellness of the animals.

The Pima County Fair is proactive in preventing the spread of Equine Herpes disease. Horse stalls are completely cleaned of waste and bedding after each use then sprayed with a Symbiont solution. Symbiont is used in the equine industry to cleanse areas that are prone to host pathogens, viruses, bacteria and fungi. Symbiont is safe and non-toxic to animals and their surroundings and is sprayed between shows, before horses arrive and after they leave the fairgrounds equine stalls.

The Southwestern Fair Commission, Inc. carefully monitors the conditions of livestock during the Pima County Fair and entrusts the enforcement of code, animal welfare and confinement of animals exhibited by junior exhibitors to the Pima County Extension Office. State and local veterinarians Dr. Staten and Dr. Grimbly monitor the health of the livestock and animals in the entertainment industry on the conditions of their confinement as well as responding to medical issues, reports of neglect or abuse of any of the animals during their confinement at the Pima County Fair.

When necessary, issues are first addressed with the Pima County Fair Barn Manager and 4-H, or the attraction operator. If the situation requires further attention, fair staff is notified and respond accordingly. Cases of animal abuse are reported to the Pima County Sheriff's Department. Doctors Staten and Grimbly visit the animals regularly to monitor the proper care and confinement of the animals for the duration of the fair. Cattle are required to be taken out of their holding area, twice daily or as often as needed. One youth exhibitor or adult must remain with the animal at all times. Cattle are tethered to protect the animals as well as the public.

The Pima County Fair will not book an animal attraction where there have been confirmed reports of prosecution for animal abuse or neglect. The Pima County Fair will research the attraction for such reports, prior to soliciting a performance engagement. Attractions who have received a minor citation but have rectified and met the requirements of the USDA, will be considered. Additionally, the Pima County Fair will research the confinement, exercise and transportation of the animals to ascertain the health and wellbeing of the animals during the fair, when it does not compromise public safety. The Pima County Fair prefers animal attractions that feature natural behaviors and animals that were either rescued or born into captivity. All attractions must have the required Pima County and/or the Arizona Department of Game and Fish permits, prior to their fair appearance.

In consideration of the well-being of all fair livestock, animals in the amusement industry and vendors or exhibitors with domestic, wild and/or endangered species, the Pima County Fair contracted veterinarian will conduct a scheduled inspection of the animal containment, confinement, display and mode of transportation for the safety and wellness of the animals. Random inspections will occur throughout the fair.

To help prevent the spread of hand to mouth pathogens related to animal attractions and livestock, hand washing and sanitizing stations are placed near all animal attractions, livestock, bathrooms and near eating areas. Signs reminding the public to wash their hands along with warnings of possible transmission of disease related to animal to human contact are placed directly at each animal attraction. Preparing, serving or eating food is not allowed in animal exhibit areas or the livestock barns.

In consideration of the well being of all fair livestock, animals in the amusement industry and vendors or exhibitors with domestic, wild and/or endangered species, the Pima County Fair contracted veterinarian will conduct a scheduled inspection of the animal containment, confinement, display and mode of transportation for the safety and wellness of the animals. Random inspections will occur throughout the fair.

The Pima County Fair Emergency Plan includes a Livestock and Animal Response Plan to address large scale emergencies, loose animals and other related issues when livestock is present along with animals in entertainment. You will receive a copy of the plan upon load in. Please review it, give input and share with your staff, to be prepared for action, when or if needed.

Additionally, the Pima County Fair Health Initiative makes the prevention of the spread of disease from animal to animal as well as animal to human a priority. If an animal confinement area appears to be neglected, unclean or unsafe for the animal, a 24-hour time period will be given to rectify the situation. If the Pima County Fair Veterinarians or USDA inspectors find your animal(s) to be unwell, the Pima County Fair reserves the right to remove you and your animals from the event and premises.

Manure dumpsters for the animal exhibits and 4-H are placed in designated areas away from the public. Manure is picked up every morning and placed in dumpsters during non-public hours. Dumpsters are then removed from the grounds daily, in the morning before opening hours. Food vendors are to remain closed during the manure removal times.

When fair weather turns from breezy to windy, animal attractions with bedding should use their spigots and hoses to lightly mist animal bedding. Spigots are equipped with a backflow prevention device. Based upon nationally recognized safety standards of the IAFE Consumer Protection Program, lightly moistening animal bedding during wind will prevent soiled bedding and other contaminated particles from blowing into the public areas where food may be consumed. Please do this regularly until the wind has stopped.

Preparing of, serving of, or eating food is not allowed in animal exhibit areas or the livestock barns.

All animal attractions, livestock areas or vendors and exhibitors with animals are required to display the attached sign, reminding fair patrons to wash their hands after handling any animal.

Thank you for your cooperation.

ATTENTION:

Teachers, Chaperones, Parents and Adults; Please enjoy the fair and help prevent the spread of infectious disease amongst children. Remind children to wash their hands and supervise their handwashing after visiting any animal exhibit and before any food consumption.

Pima County Fair Code of Conduct

We are incredibly excited to have you at the Pima County Fair! We do whatever we can to ensure that all our visitors have an enjoyable, safe time at the Fair. In so doing, the Pima County Fair must enforce prohibited items and behaviors which apply to fairgoers. Listed below are some of the common prohibited items and behaviors, but does not limit itself to the following:

No Fire Arms Allowed: Pursuant to A.R.S. 4-229 *Form 1113*

All bags will be searched. All persons and your property are subject to search.

The following items are NOT allowed into the Pima County Fair:

- Ice chests, outside food or beverages including alcohol
- Weapons or drugs
- Drones
- Selfie Sticks
- Go Pros
- Silly String or Squirt Guns
- Hover boards, bicycles, skateboards, roller skates, roller blades, razors
- Gang, inciteful or hateful attire
- Non-service animals
- Solicitation or distribution of promotional materials, literature or vending without prior written consent is prohibited.
- Professional Photography Equipment or Tripods that are not directly connected with a news affiliate
- Video Cameras and other recording devices are not allowed into the concert areas
- *The use of laser beams, flash cameras, both personal and professional may be prohibited in some instances. Information regarding this is posted at the Pima County Fair Main Gate and announcements are made from the stage. Photographing, Video or audio taping of performers can result in your equipment being temporarily confiscated and/or you may be removed from the event.*

The following behaviors are subject to prosecution and may result in being removed and banned from the Pima County Fair, without refund:

- Any illegal activity
- Acts or threats of violence
- Bootleg merchandising
- Counterfeiting of or scalping of tickets, ride passes and/or credentials
- Drunken or disorderly conduct
- Destruction of property
- Possession and/or use of illegal drugs
- Underage drinking
- Bullying
