



NAWT Onsite Installer Certified Professional Training

The NAWT installer class covers the following topics: Planning and site evaluation; Installing sewage tanks and ATUs; Installing below-ground systems; Installing above-ground systems; Installing pumps and pump stations; and Installing media filters. Additional material has been added to incorporate some of the CIDWT developed installer materials. This includes information on surveying and OSHA soil evaluation. *Attending this class qualifies for 8 CEU hours for maintaining your NAWT certification.*
