Due to the COVID-19 pandemic, the University of Arizona has canceled all in-person training until further notice. We are offering the Certified Professional Food Manager (CPFM) class virtually and referring participants to take the exam through Prometric's ProProctor service. The course is provided using Zoom and D2L Community site platforms. We will continue to facilitate the program virtually every month until further notice. Due to these changes, the registration fee is \$52. The exam portion must be completed through the Prometric ProProctor online testing website where you are responsible for paying the exam fee of \$48.
