All Master Gardeners trainees need to complete 6 of those volunteer hours directly with the Coconino Cooperative Extension office or the Coconino Master Gardener Association.

I wish to enroll in the Master Gardener training program offered by the University of Arizona Cooperative Extension Coconino County. I understand that I will be expected to attend all training sessions and provide a minimum of fifty (50) hours of volunteer service within 13 months of course completion. I further understand that I will become a Certified Master Gardener when I complete both the training and the volunteer work. I also agree to submit monthly records of my volunteer hours and contacts and to pay a one-time, non-refundable fee of \$225. To maintain certification, I will commit at least 12 hours of volunteer service and 6 hours of continuing education annually.
