What is the 4-H Cloverbud Merit Award?

The 4-H Cloverbud Merit Award is an award to recognize Cloverbud involvement in their club and on the county level. Each Cloverbud member is eligible to receive a participation disk by completing this form and submitting it by the deadline. Only Cloverbud members, (5 to 8 years of age by January 1st of current year) are eligible to receive a Cloverbud disk.

Completing the Merit Award Sheet:

- Document 4-H participation in activities and events from October 1 through September 30.
- Check all appropriate activities and provide the requested information.
- The Cloverbud and club leader must sign this completed award form. Leader's signature verifies the Cloverbud's participation in the activities indicated.
